| Citation | 1. These Regulations may be cited as the Political Parties (Registration and Monitoring) (Amendment) Regulations, 2025 and shall be read as one with the Political Parties (Registration and Monitoring) Regulations hereinafter referred to as the “principal Regulations”. |

| General amendment | 2. The principal Regulations are amended generally, by-

(a) deleting the word “age” wherever it appears and substituting for it the words “date of birth”; and
(b) deleting the words “passport size” wherever they appear and substituting for them the words “recent passport size”. |
| Amendment of regulation 3 | 3. The principal Regulations are amended in regulation 3-
(a) in subregulation (2), by-
(i) deleting paragraph (d) and substituting for it the following:
“(d) the party’s general policy which states the party’s ideology;”;
(ii) adding immediately after paragraph (i) the following:
“(j) sample of the political party’s official stamp;
(k) sample of the political party’s logo; and |

- (iii) renaming paragraphs (j) and (k) as paragraphs (l) and (m) respectively;
- (b) in subregulation (3), by-
 - (i) adding immediately after paragraph (d) the following:
“(e) sex of the member;”; and
 - (ii) renaming paragraphs (e) to (j) as paragraphs (f) to (k) respectively.

A political party shall submit a schedule of intra-party elections and candidate nominations, from the lowest level to the national level, two weeks before the intended intra-party election or nomination day.”.</p>

	<p>“Voting by 16A. Voting in every party secret ballot election shall be conducted by secret ballot.”.</p>
Amendment of regulation 17	<p>11. The principal Regulations are amended in regulation 17 by adding the words “accompanied by the register of the members of the general meeting” immediately after the word “held” appearing at the end of subregulation (2).</p>
Amendment of regulation 31	<p>12. The principal Regulations are amended in regulation 31(1) by deleting the words “regulations 21, 22, 23 and 24” and substituting for them the words “regulations 24, 25, 26, 27, 28, 29 and 30”.</p>
Amendment of regulation 35	<p>13. The principal Regulations are amended in regulation 35(2) by deleting the words “fifty thousand shillings” and substituting for them the words “five hundred thousand shillings”.</p>
Amendment of regulation 40	<p>14. The principal Regulations are amended in regulation 40 by deleting subregulation (2) and substituting for it the following:</p> <p>“(2) Any notice or information which the Registrar or political party is required to serve or give the party or Registrar under the Act or these Regulations shall be deemed to have been served if sent through registered post addressed to the party or Registrar at its postal address or if delivered by dispatch signed by the receiving agent, official, leader or any member concerned.”.</p>

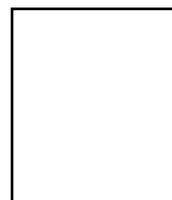

2. That the party will allow periodic and democratic elections of its leadership as provided in the constitution submitted with the application for provisional registration.

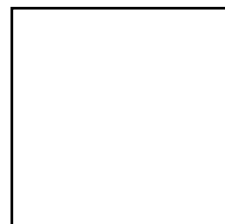

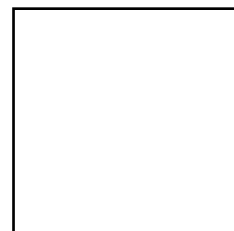
