REGULATIONS

(Made under section 47)

THE POLITICAL PARTIES (REGISTRATION AND MONITORING) (AMENDMENT) REGULATIONS, 2025

Citation

GN. No. 953 of 2019 1. These Regulations may be cited as the Political Parties (Registration and Monitoring) (Amendment) Regulations, 2025 and shall be read as one with the Political Parties (Registration and Monitoring) Regulations hereinafter referred to as the "principal Regulations".

General amendment

by-

- 2. The principal Regulations are amended generally,
- (a) deleting the word "age" wherever it appears and substituting for it the words "date of birth"; and
- (b) deleting the words "passport size" wherever they appear and substituting for them the words "recent passport size".

Amendment of regulation 3

- 3. The principal Regulations are amended in regulation 3-
 - (a) in subregulation (2), by-
 - (i) deleting paragraph (d) and substituting for it the following:
 - "(d) the party's general policy which states the party's ideology;";
 - (ii) adding immediately after paragraph (i) the following:
 - "(j) sample of the political party's official stamp;
 - (k) sample of the political party's logo; and

- (iii) renaming paragraphs (j) and (k) as paragraphs (l) and (m) respectively;
- (b) in subregulation (3), by-
 - (i) adding immediately after paragraph (d) the following:
 - "(e) sex of the member;"; and
 - (ii) renaming paragraphs (e) to (j) as paragraphs (f) to (k) respectively.

Amendment of regulation 4

4. The principal Regulations are amended in regulation 4 by adding the words "logo, flag" immediately after the word "symbol" appearing in paragraph (a).

Amendment of regulation 6

- 5. The principal Regulations are amended in regulation 6-
 - (a) in subregulation 2(c) by inserting the words "disability status, date of birth" between the words "sex" and "region";
 - (b) by renumbering subregulations (1), (2), (2), and (3) as subregulations (1), (2), (3) and (4) respectively.

Amendment of regulation 9

- 6. The principal Regulations are amended in regulation 9-
 - (a) in subregulation (3) by deleting the words "subsection (1)" and substituting for them the words "subregulation (1)";
 - (b) by renumbering the repeated subregulation (4) as subregulation (5);
 - (c) in subregulation (5) as renumbered by deleting the words "paragraph (3) of this regulation" and substituting for them the words "subregulation (4)".

Amendment of regulation 12

7. The principal Regulations are amended in regulation 12 by deleting the words "publish in the notice in the Gazette" and substituting for them the words "publish in the Gazette a notification to the public on the cancellation of such party's registration".

Addition of regulation 14A

8. The principal Regulations are amended by adding immediately after regulation 14 the following:

"Submission of names of Directorates of political party 14A. Every fully registered political party shall submit to the Registrar-

- (a) the names of its directorates; and
- (b) the names and designations of the persons heading the directorates,

within fourteen days from the establishment of the directorate or any subsequent changes thereto.".

Amendment of regulation 15

- 5. The principal Regulations are amended in regulation 15,by-
 - (a) adding immediately after subsection 2 the following:

"(2A) Every national leader of a political party shall be required to fill Form No. PP. 7D as set out in the First Schedule and submit it to the Registrar for registration."; and

(b) adding the words "recent passport size" immediately after the word "region" appearing in subregulations (2), (3) and (4).

Addition of regulation 15A

9. The principal Regulations are amended by adding immediately after regulation 15 the following:

"Submission of schedule of intra-party elections and candidate nominations 15A. A political party shall submit a schedule of intra-party elections and candidate nominations, from the lowest level to the national level, two weeks before the intended intra-party election or nomination day."

Addition of regulation 16A

10. The principal Regulations are amended by adding immediately after regulation 16 the following:

"Voting by 16A. Voting in every party secret ballot election shall be conducted by secret ballot.".

Amendment of regulation 17

11. The principal Regulations are amended in regulation 17 by adding the words "accompanied by the register of the members of the general meeting" immediately after the word "held" appearing at the end of subregulation (2).

Amendment of regulation 31

12. The principal Regulations are amended in regulation 31(1) by deleting the words "regulations 21, 22, 23 and 24" and substituting for them the words "regulations 24, 25, 26, 27, 28, 29 and 30".

Amendment of regulation 35

13. The principal Regulations are amended in regulation 35(2) by deleting the words "fifty thousand shillings" and substituting for them the words "five hundred thousand shillings".

Amendment of regulation 40

- 14. The principal Regulations are amended in regulation 40 by deleting subregulation (2) and substituting for it the following:
 - "(2) Any notice or information which the Registrar or political party is required to serve or give the party or Registrar under the Act or these Regulations shall be deemed to have been served if sent through registered post addressed to the party or Registrar at its postal address or if delivered by dispatch signed by the receiving agent, official, leader or any member concerned."

Deletion and substitution of First and Third Schedules

15. The principal Regulations are amended by deleting the First and Third Schedules and substituting for them the following:
