REGULATIONS

(Made under section 31)

THE ELECTION EXPENSES (AMENDMENT) REGULATIONS, 2025

Citation

1. These Regulations may be cited as the Election Expenses (Amendment) Regulations, 2025 and shall be read as one with the Election Expenses Regulations hereinafter referred to as the "principal Regulations".

2. The principal Regulations are amended in regulation 4(2) by deleting the word "age" appearing in

- "(b) details of the bank account;"; and
- (b) renaming paragraphs (b), (c) and (d) as paragraphs (c), (d) and (e) respectively.

Amendment of regulation 13

- 4. The principal Regulations are amended in regulation 13(1) by deleting the words "District Administrative Secretary and the Ward Executive Officer" and substituting for them the words "Returning Officer and Assistant Returning Officer".
- 5. The principal Regulations are amended by

 deleting regulation 15 and substituting for it the following:

Deletion and substitution of regulation 15

"Report, funds, verification and submission of returns

- 15.-(1) A candidate in a general election or by-election shall prepare a financial report of election expenses pursuant to section 18 of the Act.
- (2) The financial report of election expenses prepared under subregulation (1) shall be in Form EE.11 set out in the Schedule to these Regulations.
- (3) Upon receipt of the report from the candidate, the Secretary General, shall before submitting that report to the Board of Trustees, verify the correctness of the report and may, where necessary request additional information from the particular candidate for purposes of satisfying himself.
- (4) Upon receipt of the financial report, the Board of Trustees shall submit the report to the Registrar in Form EE.12, set out in the Schedule to these Regulations, containing the following particulars:
 - (a) an account of funds received;
 - (b) an account of or expenses incured;
 - (c) bills and receipts; and
 - (d) amount of funds apportioned to candidates sponsored by that political party.
- (5) Subject to section 13 of the Act, the management of an organisation which participated in advocacy or public awareness activity shall submit a report of true returns in Form EE.13 set out in the Schedule to these Regulations containing the follo
